This is prepared as my response to an MFIPPA request for information, dated June 18, 2025, per SCHEDULE "A". The information is from the detailed General Ledger printouts that I was able to locate. As previously noted, I was unable to locate the period before 2000, so 1998 and 1999 will be missing from the request, and 2000-2003 had no expenses in the account entitled "Point Park Litigation". Additionally, I have found that the "Details" of the invoices was not always clear when entered in the General Ledger, often it states "Point Park/ Two Chain", of which I am unable to determine with certainty where the expenses belong.
